

WARRANT FOR ANNUAL TOWN MEETING

March 25, 2024

6:30 pm Kristy Crawford opens the meeting.

Article 1:

To choose a Moderator to preside over said meeting. **Kenneth Colson nominated Winthrop "Ted" Carter. 5 votes for Ted Carter. Ted Carter Appointed Skip Colson as Deputy Moderator.**

Article 2

To see what the town will vote to fix for the salary of the Board of Selectmen (was \$1,600.00 = \$320.00 per selectmen 26.67 per monthly meeting). Selectmen recommend \$1600. **Motion made by Stephen Seavey, seconded by Joseph Manza. 29 Yes 1 No. Motion passed.**

Article 3

To see what the town will to fix for the salary of the Board of Assessors (was \$3,500.00 = to \$1,116.00 per assessor). Selectmen recommend \$3500.00. **Motion made by Stephen Seavey seconded by Jennifer Sanford 27 Yes, 2 No, 1 Spoiled. Motion passed.**

Article 4

To see what the town will vote to fix for the salary of the Planning Board (was \$0.00) per Planning Board Request. Selectmen recommend \$0.00. **Motion made by Brittany Seavey seconded by Amanda Posick. 35 Yes 0 No. Motion passed.**

Article 5

To see what the town will vote to fix for the salary of the School Board (was \$500.00 = to \$100.00 per member) Selectmen recommend \$500.00. **Motion made by Emogene Hill seconded by Elizabeth Carter. 26 Yes 1 No. Motion passed.**

Article 6

To see what sum the Town will raise as a compensation package for the Town Clerk/Tax Collector/Treasurer/Assistant to Town Boards. Selectmen recommend Total \$67,817.52 \$32,400 to be used as an annual salary to be paid out (bi-weekly).

If the Town Clerk/Tax Collector/Treasurer opts out of Health Insurance the position would receive a yearly stipend of \$3500.00 to be paid bi-weekly. **Motion made by Josie Wallace seconded by Amanda Posick. 23 Yes 9 No. Motion passed.**

Article 7

To see what the town will vote to fix the wages of the Deputy Town Clerk/Tax Collector/Treasurer. The Selectmen recommend \$8,000. (\$14.15-18.00 /hr. depending on experience). Any amount over the \$8,000.00 shall be paid from the Town Clerk/Tax Collector/Treasurer's salary. **Motion made by Stephen Seavey seconded by Jason Croman 28 Yes, 4 No. Motion passed.**

Article 8

To see what the town will vote to fix for the wages of all other employees. Selectmen recommend:
To fix wages for all other employees at D.O.T. scale for road work and cemetery work. \$15.00 per hour for Elections, and minimum wage, for all others. **Motion made by Stephen Seavey seconded by Brett Crawford. 30 Yes 1 No 1 Spoiled. Motion passed.**

Article 9

To elect a Selectperson for a three-year term. **David Davis and Foster Carlow Jr. were nominated. 33 votes for David Davis, 4 votes for Foster Carlow Jr. David Davis elected.**

Article 10

To elect a Selectperson for a three-year term. **Foster Carlow Jr. and David Sanford were nominated. 17 votes Foster Carlow Jr. 20 votes David Sanford. David Sanford elected.**

Article 11

To elect a Selectperson for a two-year term. **Carl Oakes and Foster Carlow Jr. were nominated. 31 votes for Carl Oakes 6 votes for Foster Carlow Jr. Carl Oakes elected.**

Article 12

To elect a Selectperson for a one-year term. **Foster Carlow Jr. was nominated. 27 votes for Foster Carlow Jr. 2 spoiled votes. Foster Carlow Jr. elected.**

Article 13

To elect an Assessor for a three-year term. **Merle Knowles III was nominated. 30 votes for Merle Knowles III. Merle Knowles III was elected.**

Article 14

To elect a member of the School Board for a constitutional term of three years. **Amanda Posick was nominated. 23 votes for Amanda Posick. Amanda Posick was elected.**

Article 15

To elect a member of the School Board for a constitutional term of three years. **Logan Lord was nominated. 26 votes for Logan Lord 1 spoiled vote. Logan Lord was elected.**

Article 16

To elect a member of the Planning Board for a five-year term. **Ray Carter was nominated 23 votes for Ray Carter. Ray Carter was elected.**

Article 17

To elect one or more Overseers of the Poor for the ensuing year. **The Selectmen were nominated. 31 votes for the selectmen. The Selectmen were elected.**

Article 18

To elect a Cemetery Caretaker(s) for the ensuing year. **The Selectmen were nominated. 30 votes for the selectmen. The selectmen were elected.**

Article 19

To see if the Town of Alexander will vote to appropriate \$12,000 from the Unassigned Fund Balance to the Administrative Account. **Motion was made by Stephen Seavey and Amanda McDonough. 27 Yes 1 No. Motion passed.**

Article 20

To see if the Town of Alexander will accept grants from state and federal agencies, foundations, and contributions from businesses and individuals designated for the Alexander Broadband Project. **Motion was made by**

Stephen Seavey seconded by Emogene Hill. 31 Yes 0 No. Motion passed.

Article 21

To see if the Town of Alexander will accept grants from state and federal agencies, foundations, and contributions from businesses and individuals designated for the Alexander Cemetery Restoration. **Motion was made by Stephen Seeley seconded by Ronnie Seeley. 34 Yes 0 No. Motion passed.**
